WHEREAS, CHEVRON U.S.A. INC., a corporation, is now the owner of the Lessee's interest in and to said Lease.



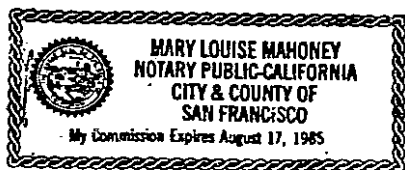
