SURRENDER OF GEOTHERMAL RESOURCES LEASE

WHEREAS, PETER P. PRUCE, as Lessor, entered into that certain Geothermal Resources Lease with AMERICAN THERMAL RESOURCES, INC., a corporation as Lessee, dated April 11, 1972, hereinafter called "said Lease," a short form of which was recorded October 2, 1972, as File No. 56745, Book 43, Pages 483-485, Official Records of Eureka County, Nevada; and

WHEREAS, by virtue of that certain Assignment of Lease Agreement dated June 15, 1976, recorded July 1 1976 as Document No. 083201, in Lander County, Nevada, and recorded July 7, 1976 as Document No. 61624, in Eureka County Nevada, an undivided 62½% of said Lease was assigned from AMERICAN THERMAL RESOURCES, INC. to CHEVRON OIL COMPANY, a corporation; and

WHEREAS, by virtue of that certain Amendment of Lease Agreement dated February 1, 1977, a short form of which was recorded June 16, 1977, as File No. 63107, Book 59, Pages 254-256, of said Official Records, said Lease was amended as therein provided; and

WHEREAS, by virtue of that certain Assignment of Lease Agreement dated March 3, 1978 recorded March 29, 1978, as Document No. 089809 in Lander County, Nevada, and recorded April 10, 1978, as Document No. 64832 in Eureka County, Nevada, the remaining undivided 37½% of said Lease was assigned from AMERICAN THERMAL RESOURCES, INC. to CHEVRON U.S.A. INC., a corporation, formerly CHEVRON OIL COMPANY, a corporation, reserving unto Assignor a 2% overriding royalty.

NOW, THEREFORE, this instrument of Surrender WITNESSETH: That CHEVRON U.S.A. INC., does hereby terminate and Surrender all of its right, title and interest in and to said Lease, which Lease covers

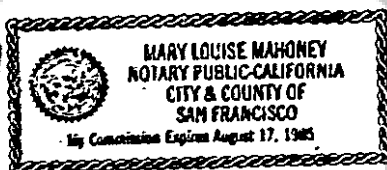
