

REVOCATION  
OF  
LIMITED POWER OF ATTORNEY

WHEREAS, by Limited Power of Attorney dated February 14, 1983, Marathon Oil Company, an Ohio Corporation, made and appointed Robert H. Steed, its Casper Division Exploration Manager, as its true and lawful attorney, granting to the said Robert H. Steed full power and authority to execute for it and in its name, place and stead:

- (a) Oil and gas leases taken in the name of the Company, as Lessee, or assigned to it, and amendments and ratifications of such leases;
- (b) Assignments, releases and cancellations thereof;
- (c) Unit agreements, division orders, farm-out agreements, and right-of-way agreements;
- (d) Change of depositories and subordination agreements limited to subordinating others' interests to that of the company; and,
- (e) Instruments, contracts, and agreements relating to drilling, operation and development of the Company's properties.

WHEREAS, said Robert H. Steed, attorney in fact, is no longer serving Marathon Oil Company in the capacity above stated.

NOW, THEREFORE, in accordance with rights specifically reserved by Marathon Oil Company, said Limited Power of Attorney is hereby revoked, effective July 1, 1984.
