S 60° W direction and 1490 feet in a N 60° E direction from the location monument, at
which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width
on each side of the center of the claim. The general course of the lode deposit and premises is from
the southwest to the northeast.

The location and number of each corner of this claim is shown on the claim map that is filed
