CERTIFICATE OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the IBM 26 lode mining claim in an unorganized Mining District, Eureka County, in the State of Nevada on the 20 day of July, 1984, for Thomas E. & Frances Bilbao, Box 537, Elko, Nevada 89801.

This claim is located in the Township 31 North, Range 51 East, of the Mount Diablo Meridian in the following one quarter section(s) of the Public Domain: Eureka County, Nevada.

*SW<sup>1</sup>/<sub>4</sub> of Sec 21, NW<sup>1</sup>/<sub>4</sub> of Sec 28*

The claim is 1000 feet long and 600 feet wide and 990 feet is claimed in a North direction along the length of the claim and 10 feet is claimed in a South direction along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location, and markings on each boundary or corner monument is as follows:

As erected on the ground each boundary or corner monument is marked as described above by permanent marking ink on the post.

The monumentation and markings of the above mentioned corners on the ground was completed by the 27th day of July, 1984, and the location work consisted of making a claim map as provided in NRS: 517.040. Two copies of this may have been filed with the Eureka County Recorder and the \$20.75 lode claim filing fee has been paid to the County Recorder.
