## CERTIFICATE OF LOCATION - NEVADA

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 1490 feet from the NORTH end and 10 feet from the SOUTH end.

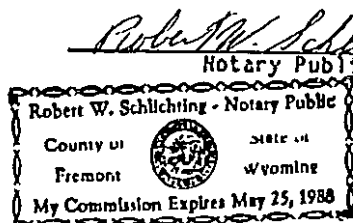
