Thence, <u>600</u> feet in a <u>WEST</u> direction to Post No. 4,

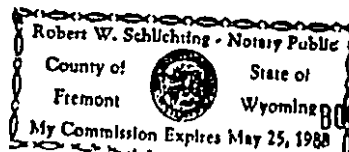
