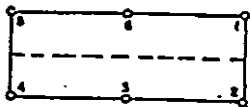

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1632 Lode Mining Claim on this 2 day of JULY, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 34 Township 22 N., Range 50 E., Mt. Diablo P.M., and more particularly described as follows, to wit:

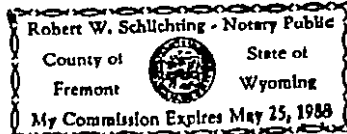
