## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1171 Lode Mining Claim on this 25th day of June, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.

Said Claim is located in the NW (SW) (Quarter) Section(s) 27 (22) Township 23 N., Range 49 E., Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>750</u> feet in a <u>SOUTH</u> direction to Post No. 2,
Thence, <u>750</u> feet in a <u>SOUTH</u> direction to Post No. 3,
Thence, <u>600</u> feet in a <u>WEST</u> direction to Post No. 4,
Thence, <u>750</u> feet in a <u>NORTH</u> direction to Post No. 5,
Thence, <u>750</u> feet in a <u>NORTH</u> direction to Post No. 6,
Thence, <u>600</u> feet in a <u>EAST</u> direction to Post No. 1,

the point of beginning and all posts being 4" x 5'.

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the NORTH end and 1490 feet from the SOUTH end.

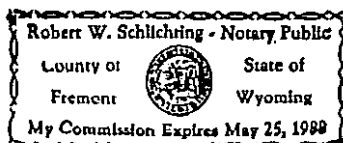
