## CERTIFICATE OF LOCATION OF MILL SITE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that CORTEZ GOLD MINES, a joint venture consisting of Placer U.S. Inc., Kennecott Corporation and Vernon Taylor, Jr., having a post office address of Cortez, NV 89821, has located the M. 1007 mill site on the 29<sup>th</sup> day of JULY, 1984 and claims, under and by virtue of the mining laws of the United States of America and the State of Nevada, 650 feet in a S.4°15'E., direction and 10 feet in a N.4°15'W., direction and 165 feet on each side of the center of the claim from the location monument, at which the Notice of Location is posted, and contains 5.00 acres more or less.

Said mill site is located in conjunction with the Cortez Gold Mine; and said mill site is situated in the Cortez Mining District, County of Eureka, State of Nevada, and is more particularly described as follows:

On each such post is a scribed metal tag marked so as to designate the part of the mill site upon which the same is located.
