WITNESSETH

That the said parties of the first part, for and in consideration of the sum of One Dollar (\$1.00), lawful money of the United States of America, and other good and valuable consideration the receipt whereof is hereby acknowledged, do hereby grant, bargain and sell unto the said parties of the second part, in joint tenancy and to the survivors of them and to the heirrs of such survivor forever, all of their undivided interest, in and to those certain lots and parcels of land situate in the Town of Eureka, County of Eureka, State of Nevada, and more particularly described as follows:
