## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1120 Lode Mining Claim on this 24th day of June, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 1490 feet from the NORTH end and 10 feet from the SOUTH end.

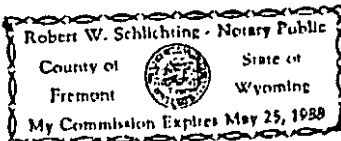
