CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the under-  
signed, does hereby locate the JASPER 1134 Lode Mining Claim on this  
24th day of June, 1984, situated in the UNKNOWN Mining  
District, Eureka County, Nevada.

Said Claim is located in the NE (SE) (Quarter) Section(s) 26 (23),  
Township 23 N., Range 49 E., Mt. Diablo P.M., and more particularly  
described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>750</u> feet in a <u>SOUTH</u> direction to Post No. 2,
Thence, <u>750</u> feet in a <u>SOUTH</u> direction to Post No. 3,
Thence, <u>600</u> feet in a <u>WEST</u> direction to Post No. 4,
Thence, <u>750</u> feet in a <u>NORTH</u> direction to Post No. 5,
Thence, <u>750</u> feet in a <u>NORTH</u> direction to Post No. 6,
Thence, <u>600</u> feet in a <u>EAST</u> direction to Post No. 1,

the point of beginning and all posts being 4" x 5".

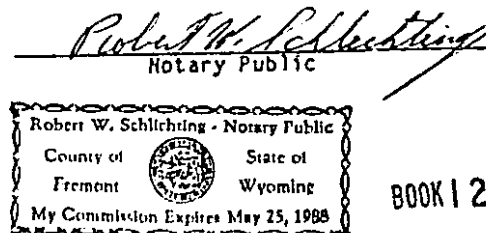
