## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1270 Lode Mining Claim on this 26th day of June, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.

Said Claim is located in the NW (SW) (Quarter) Section(s) 14 (1b), Township 23 N., Range 49 E., Mt. Diablo P.M., and more particularly, described as follows, to wit:

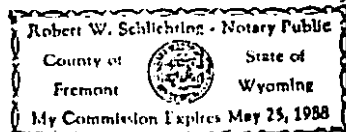
