CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that **ATLAS CORPORATION**, by its Agent, the undersigned, does hereby locate the **JASPER 1275** Lode Mining Claim on this 26th day of **June**, 1984, situated in the **UNKNOWN** Mining District, **Eureka** County, Nevada.

Said Claim is located in the **NE (NW) (SE) (SW) (Quarter)** Section(s) **23 (23) (14) (14)**, Township **23 N.**, Range **49 E.**, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

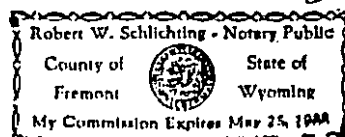
