CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1300 Lode Mining Claim on this 26th day of June, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.

Said Claim is located in the NE (SE) (Quarter) Section (e) 15 (10) Township 23 N., Range 49 E., Mt. Diablo P.M., and more particularly described as follows, to wit:

the point of beginning and all posts being 4" x 5'.
