CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1429 Lode Mining Claim on this 24th day of June, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.
