## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1615 Lode Mining Claim on this 1st day of July, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.


