CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby locate the JASPER 1607 Lode Mining Claim on this 7th day of July, 1984, situated in the UNKNOWN Mining District, Eureka County, Nevada.

Said Claim is located in the SW (SE) (NE) (Quarter) Section(s) 35 (35) (2) Township 23N. (23N) (22N), Range 49E. (49E.) (49E.), Mt. Diablo P.M., and more particularly described as follows, to wit:

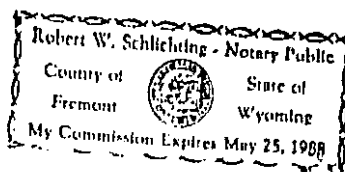
