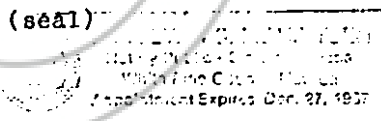

Cost of work performed: At least \$100.00 was spent on each claim.

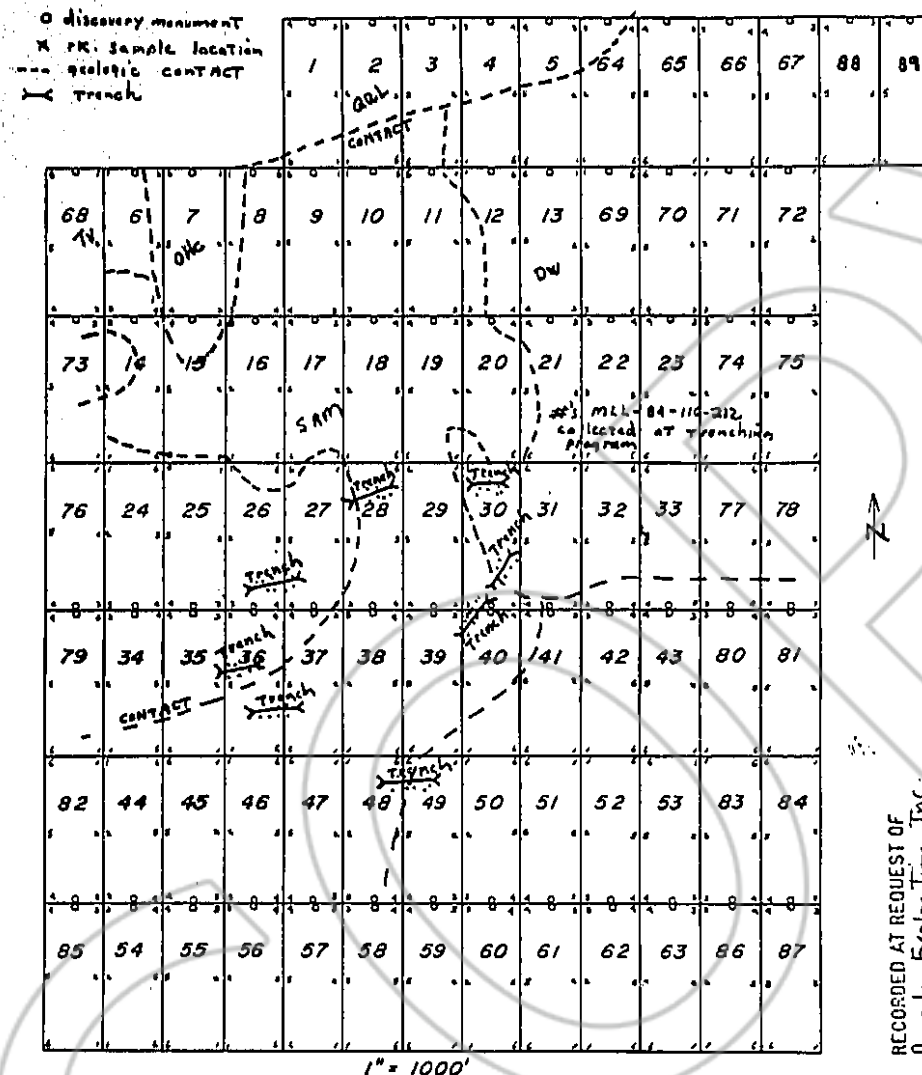
