

**CERTIFICATE OF LOCATION  
LODE MINING CLAIM**

KNOW ALL MEN BY THESE PRESENTS that the undersigned locators, having complied with all of the requirements of law and local rules and customs, have claimed and claim by right of discovery and location, a lode mining claim situated in an Unknown Mining District, County of Eureka, State of Nevada, and hereby certify that:

(a) The name of said lode or vein and lode mining claim is:

(c) Said mining claim was located on July 19th, 1984, in about Section 8, Township 34 North, Range 48 East, M.D.B. & M., and is bounded and described as follows:

Commencing at the SE Corner which bears 300 feet Southerly and 1475 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 1500 feet in a N. 1° 00' E. direction from the Quarter Corner of Sections 8 and 17, Township 34 North, Range 48 East, M.D.B. & M. This lode claim, RCK No. 19, is Northerly of RCK No. 17, Southerly of RCK No. 21, Easterly of RCK No. 20, and Westerly of RCK No. 39, lode claims.

(d) The undersigned claim 1500 feet linear and horizontal in measurement along the course of the vein, together with 300 feet in width along the course of the vein, 25 feet of said lode running Westerly from the point of discovery (designated by the location monument). The general course of the lode as near as may be presently determined is Easterly and Westerly.

(e) Since the date of said location and prior to the date of this certificate, the undersigned caused work to be performed upon said mining claim consisting of maps as provided by NRS 517.040.

(f) The location monument, each corner and side line center marker is in each instance represented by a post at least 4 inches in diameter by 4½ feet in length and set 1 foot in the ground, the respective corner posts being marked as follows: SE Corner, RCK No. 19; SW Corner, RCK No. 19; NW Corner, RCK No. 19; and NE Corner, RCK No. 19.
