THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2800 FT (N 30 1/2 W) FROM THE SE CORNER OF SECTION 35, TOWNSHIP 22N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 OF SEC 35 T22N R50E M.D.M & S. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS TO FEET IN A/N NORTH DIRECTION, AND 1490 FEET IN A/S SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
