THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3200 FT (N44W) FROM THE SE CORNER OF SECTION 35, TOWNSHIP 22N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE & SE 1/4 SEC 35 T22N R50E M.D.M. & B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N SOUTH DIRECTION, AND 1490 FEET IN A/N NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
