THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2340 Ft (N1/2W) FROM THE southeast CORNER OF SECTION 35, TOWNSHIP 22N RANGE 5DE, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE & SE 1/4s OF Sec 35, T22N, R50E, M.D.M. & B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS TO FEET IN A/AN south DIRECTION, AND 1490 FEET IN A/AN north DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
