THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2330 FT (N 10 1/2 W) FROM THE SE CORNER OF SECTION 35, TOWNSHIP 22N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 35 T22N R50E M.D.M. & B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N North DIRECTION, AND 1490 FEET IN A/S south DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
