THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 890 FT (N26 1/2 W) FROM THE SE CORNER OF SECTION 35, TOWNSHIP 22N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 SEC 35 T22N R50E & the NE 1/4 SEC 2 T21N R50E, M.D. 16. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N NORTH DIRECTION, AND 1490 FEET IN A/N South DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
