THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1200 FT (N 52 1/2 W) FROM THE SE CORNER OF SECTION 35, TOWNSHIP 22N, RANGE 51E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 of Sec 35 T22N R50E E the NE 1/4 Sec 3 T21N R50E MDM & B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N NORTH DIRECTION, AND 1490 FEET IN A/N South DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
