THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1800 FT (N64 1/2 W) FROM THE SE CORNER OF SECTION 35, TOWNSHIP 22N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 SEC 35, T22N R 50E and the NE 1/4 of sec 2 T22N R 50E AND FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS TO FEET IN A NORTH DIRECTION, AND 1490 FEET IN A south DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.R.S. SECTION 517.030.
