(S33E) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23 1/2 N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 6 T23N R51E, MDMB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N 52°24'30"E DIRECTION, AND 1490 FEET IN A/N N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
