THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 7290 FT (S13E) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23 1/2 N, RANGE 50 E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec 6, T23N, R51E, MDM 18. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N S2°24'30"E DIRECTION, AND 1490 FEET IN A/N N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
