(543.5 W) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23 1/2 N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 1 T23 1/2 N, R50E & the NE 1/4 Sec 1 T23 N, R50E, MDM & B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS TO FEET IN A/N S 2° 24' 30" E DIRECTION, AND 1490 FEET IN A/N N 2° 24' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
