THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1555 FT (559.5W) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23 1/2 N, RANGE 50 E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 1, T23 1/2 N, R50 E, & the NE 1/4 Sec 1, T23 N, R50 E, M D M B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN S2°24'30"E DIRECTION, AND 1490 FEET IN A/AN N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
