THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1310 FT (NIE) FROM THE SOUTHWEST CORNER OF SECTION 6, TOWNSHIP 23N RANGE 51E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 1, NE 1/4 Sec 12, T23N R50E & SW 1/4 Sec 6, T23N R51E, MDMB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/AN S2°24'30"E DIRECTION, AND 1490 FEET IN A/AN N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
