THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2650 Feet (528.5 W) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23 1/2 N, RANGE 50 E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec 1, T23N, R50E, MDM 1B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N DIRECTION, AND 1490 FEET IN A/N DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
