THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3410 Feet (S53W) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23^{1/2} N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 SW 1/4 Sec 1 T23N, R50E, MDM 3 B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N N2°24'30"W DIRECTION, AND 1490 FEET IN A/N S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
