(N 57 W) FROM THE SOUTHWEST CORNER OF SECTION 6, TOWNSHIP 23 N RANGE 51 E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec 12 T23N R50E MDMB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N N27°24'30" W DIRECTION, AND 1490 FEET IN A/N S2°24'30" E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
