FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N N2 1/2 30 W DIRECTION, AND 1490 FEET IN A/N S2 1/2 30 E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
