(S86.5W) FROM THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 24N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 NW 1/4 of Section 1, T23 1/2 N, R50E MDM 18. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 10 FEET IN A/N N12°24'30"W DIRECTION, AND 1490 FEET IN A/N S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
