THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 600 Ft (S 88 W) FROM THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 24 N RANGE S0E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 35 T24N R50E & the NE 1/4 Sec. 1, T23 1/2 N, R50E, MDM 18. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/AN S2°24'30"E DIRECTION, AND 1480 FEET IN A/AN N2°24'30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
