(S78W) FROM THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 24N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 Section 1, T23 1/2 N, R 50E, MDM 1 B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N N2°24'30"W DIRECTION, AND 1480 FEET IN A/N S 2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
