(S78W) FROM THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 24N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 Section 1, T23 1/2 N, R 50E, MDM 1 B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N N2°24'30" W DIRECTION, AND 1480 FEET IN A/N S 2° 24' 30" E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
