(S 85E) FROM THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 24N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 Section 6, T23N, R51E, MDM 1 B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N N 2° 24' 30" W DIRECTION, AND 1480 FEET IN A/N S 2° 24' 30" E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.R.S. SECTION 517.030.
