(N 1.5 W) FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 23 1/2 N, RANGE 50 E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec 1, T23 1/2 N, R50 E & the NW 1/4 Sec 6 T23, R51 E, MDM 1 B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 20 FEET IN A/N S 2° 24' 30" E DIRECTION, AND 14.80 FEET IN A/N N 2° 24' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
