THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 4190 Ft (N48W) FROM THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 24N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW & NW 1/4's of Section 35, T24N, R50E, MON 18. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN A/N N2°24'30"W DIRECTION, AND 1490 FEET IN A/N S 2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
