CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that N. L. Baroid/N. L. Industries, Inc., having an office and place of business at P.O. Box 1675, Houston, Texas, 77251, owner of the CC #1 lode mining claim, originally located on July 30, 1980, recorded in Book 85, Page 27, of Eureka County, Nevada, did on the 18th day of September, 1984, amend, locate and claim by right of original discovery and location the land hereinafter described as a lode mining claim under, pursuant to and in compliance with the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 750 feet in a N12°E direction and 750 feet in a S12°W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course or strike of the vein or lode as near as may be determined is N12°E and S12°W.

The claim is located in the:

The location work consisted of making a mining claim map as provided in Nevada Revised Statutes 517.040. Two copies of this map are filed in the records of Eureka County, Nevada.

The location monument, corners and side centers are each 4-inch diameter P.V.C. pipe posts 5' in length, set ' in the ground or mound of stone. The location and markings on each corner and side center are more particularly described as follows:

The monumentation and marking of the corners was completed by the 25th day of September, 1984.

If this amended lode mining claim should be, at the time of this amendment, ineffective for any reason as to any of the ground within the boundaries herein defined, then as to such ground this Amended Certificate of Location shall be an original location.
