TITLE: REPORT ON A GEOLOGICAL INVESTIGATION CONDUCTED ON THE LYDALL #20,  
22, 24, 37-39, 118-121 CLAIM GROUP

This report is in compliance with the Bureau of Land Management Circular No. 2289, "Regulations Pertaining to Mining Claims Under the General Mining Laws of 1872." (as contained in Title 43 of the Code of Federal Regulations.) Subpart § 3851.2, Inclusion of Surveys in Assessment Work.

Lyndall Claims Numbers 20, 22, 24, 37-39, 118-121 are in Sections 29 and 32 of T23N, R50E MDB&M, Eureka County, Nevada.

A geological investigation was carried out in July of 1984 by Fred Hilton and Dan Aubrey, geologists for All Minerals Corporation, for the purpose of determining the relationship of the structures on claim #38 to the geochemical anomalies previously determined and correlation with the drill holes previously drilled. Samples were taken at five points in the northeast half of claim #38. The area was closely examined. From the investigation it was concluded that the fluids giving rise to the evident mineralization had traveled along the major thrust fault exposed in the area.
