On the 21st of August, 1984, the Plaintiffs above-named, by and through their Attorney, MARK D. 1. That pursuant to the terms of the ORDER FOR PUBLICATION OF SUMMONS, entered herein on the 21st day of August, 1984, the Defendants were personally served with Summons and Complaint on the 28th day of August, 1984, in the City of Tome, the County of Valencia, and the State of New Mexico, and that said Defendants have failed to appear and answer the Plaintiff's FIRST AMENDED COMPLAINT, filed herein.

2. That the legal time for answering has expired and no answer or response or pleading has been filed within the said time by the Defendants, RICHARD K. MULVANEY, BOBBIE J. MULVANEY, and CARICO LAKE MINING COMPANY.

3. That the Default of said Defendants has been duly and regularly entered according to law.
