CERTIFICATE OF LOCATION

(LODE)

NOTICE is hereby given that the AT 15 lode mining claim has been located by KENNECOTT CORP., whose office is located at P.O. Box 11248, Salt Lake City, Utah 84147.

By right of discovery, the locator does hereby claim all valuable minerals together with all extralateral variations allowed by law. This claim is 1500 feet in length, and 600 feet in width. The general course of this claim is N-S, and is situated in the UNKNOWN Mining District, EUREKA County, State of NEVADA. This claim runs from the location monument upon which this notice is posted, 300 feet in a SOUTH direction to the S end line, and 1500 feet in a NORTH direction to the N end line, together with 300 feet on each side of the center of the vein.

This claim is monumented by six posts, one at each corner and one at the center of each side line of the claim, taking the form of a parallelogram. The claim LOC. MONUMENT is situated in the SUN quarter of Section 20, Township 23N, Range 5DE, MDSM. * NOTE: THIS IS A PROTRACTED GRID

The location of this claim in relation to some natural object or permanent monument is as follows: THE NE COR OF AT 15 IS APPROX. 18,090 IN A S23W DIRECTION FROM ROCKETS CREEK MTR.

The boundaries of this claim can be identified by the following description. BEGINNING AT THE NE CORNER OF THE CLAIM, ALSO KNOWN AS CORNER NUMBER ONE:

THENCE <u>SOUTH</u> <u>750</u> FEET	TO THE <u>E</u> SIDE CENTER
THENCE <u>SOUTH</u> <u>750</u> FEET	TO CORNER NUMBER TWO;
THENCE <u>WEST</u> <u>600</u> FEET	TO CORNER NUMBER THREE;
THENCE <u>NORTH</u> <u>750</u> FEET	TO THE <u>W</u> SIDE CENTER
THENCE <u>NORTH</u> <u>750</u> FEET	TO CORNER NUMBER FOUR;
THENCE <u>EAST</u> <u>600</u> FEET	TO THE POINT OF BEGINNING

All monuments consist of 4" by 4", PVC posts at least 4 1/2 feet in length, and set in a mound of stones where such stones are available. All monuments are marked in a permanent manner so as to identify the monuments.

This claim is contiguous to, and bounded by the following claims:

AT on the North.
AT 16 on the South.
AT on the West.
AT 17 on the East.
