

PARTIAL ASSIGNMENT

For valuable consideration received, SHELL WESTERN E&P INC., herein called "SWEPI", hereby transfers and assigns an undivided twenty-five percent (25%) interest to Hunt Oil Company of Nevada, its successors and assigns, herein called "Assignee", without warranty of title, express or implied, and subject to the provisions set out below, of SWEPI's right, title and interest in and to the oil, gas and mineral lease described in Exhibit "A", attached hereto, insofar and only insofar as said lease covers the respective tracts of land described therein.

This Assignment is made pursuant to, and the land and lease described in Exhibit "A" attached hereto, is made subject to the terms and provisions of that certain Agreement dated May 1, 1980, between Shell Oil Company and Hunt Oil Company, the terms and provisions of which contract are hereby incorporated in and made a part of this assignment to the same extent as though set out herein.

SWEPI shall handle payment of all delay rentals coming due under the lease herein assigned subsequent to the effective date hereof, and upon receipt of notice from SWEPI that such delay rental has been paid, Assignee shall reimburse SWEPI for their proportionate share of the amount thereof. SWEPI agrees to use reasonable care in making payment of such delay rental but shall not be liable or responsible to Assignee for failure to pay or for improper payment thereof.


Assignee shall comply with and hereby assumes all express and implied covenants and obligations contained in the leases as to the interests herein assigned.

This assignment shall be effective as of January 1, 1984,


