

CERTIFICATE OF LOCATION

NOTICE is hereby given that the TSH-28 lode mining claim has been located by KENNECOTT, whose office is located at P.O. Box 11248, Salt Lake City, UT 84147.

By right of discovery, the locator does hereby claim all valuable minerals together with all extralateral variations allowed by law. This claim is 1500 feet in length, and 600 feet in width. The general course of this claim is E-W, and is situated in the UNKNOWN Mining District, EUREKA County, State of NEVADA. This claim runs from the location monument upon which this notice is posted, 50 feet in a WEST direction to the W end line, and 1450 feet in a EAST direction to the E end line, together with 300 feet on each side of the center of the vein.

This claim is monumented by six posts, one at each corner and one at the center of each side line of the claim, taking the form of a parallelogram. The claim is situated in the NW/NE quarter of Section 2, Township 18N, Range 49E, MDB&M.

The location of this claim in relation to some natural object or permanent monument is as follows: CORNER #1 LIES SOUTH WEST 1800 FEET AND WEST 3000 FEET FROM THE NE CORN. OF SEC. 2, T. 18N, R. 49E.

The boundaries of this claim can be identified by the following description. BEGINNING AT THE NW CORNER OF THE CLAIM, ALSO KNOWN AS CORNER NUMBER ONE:
THENCE SOUTH, 600 FEET TO CORNER NUMBER TWO;
THENCE EAST, 750 FEET TO THE S SIDE CENTER;
THENCE EAST, 750 FEET TO CORNER NUMBER THREE;
THENCE NORTH, 600 FEET TO CORNER NUMBER FOUR;
THENCE WEST, 750 FEET TO THE N SIDE CENTER;
THENCE WEST, 750 FEET TO THE POINT OF BEGINNING.

All monuments consist of 4" by 4", PVC posts at least 4 1/2 feet in length, and set in a mound of stones where such stones are available. All monuments are marked in a permanent manner so as to identify the monuments.

This claim is contiguous to, and bounded by the following claims:

- TSH-30 on the North.
- on the South.
- TSH-27 on the West.
- TSH-1 on the East.
